Child Safety and Wellbeing Policy

Purpose

The purpose of this policy is to demonstrate Kentish Regional Clinic's commitment to the safety and wellbeing of children and young people and to inform all leaders, staff and volunteers of their obligations to act ethically towards children and their roles and responsibilities in ensuring the safety and wellbeing of children.

This policy applies to Staff and Volunteers.

This policy applies to all activities in the organisation that involve, result in or relate to contact with children.

Responsibilities

Kentish Regional Clinic will ensure:

All **staff** have a current Working with Vulnerable People card, Blue Card or state equivalent and/or have a current National Police Check as required for program/funding.

All **volunteers** have a current Working with Vulnerable People card, Blue Card or state equivalent.

Kentish Regional Clinic will:

Identify risks to child and youth safety and focus on how these may be prevented or minimised;

• Require all staff to demonstrate their commitment to child and youth safety through their agreement to act in accordance with the Kentish Regional Clinic Child Safe Code of Conduct;

Complete appropriate suitability screening for all staff working with children and youth;

- Require relevant staff to complete appropriate child and youth safety education and training;
- Engage proactively with parents, guardians, specified next of kin, and other agencies involved in the protection of children and young people;

Develop and implement a clear process for reporting and responding to disclosures, suspicions, and allegations of abuse or neglect in accordance with legislation;

• Develop and implement processes to identify and address breaches of this framework;

Undertake regular review of this framework to ensure it remains current and reflects emerging requirements and current best practice.

Definitions

Child/children – applies to any person from birth to 18 years old Child harm or abuse – includes but is not limited to emotional, physical, sexual Mandatory reporting – as defined by Children, Young Persons and Their Families Act 1997 Board members – refers to any person currently serving on the Board of Management Staff – refers to any person currently employed with Kentish Regional Clinic Volunteers – refers to any person volunteering for Kentish Regional Clinic for any amount of time
